# APPENDIX E – LAND DESCRIPTION OF THE PROJECT AREA ACROSS FEDERAL LANDS

---

Appendix E will contain the legal description of federally managed lands crossed by the Boardman to Hemingway Transmission Line (Project) in Oregon and Idaho. The descriptions will be separated by type of right-of-way grant requested. In addition to the temporary grants requested for workspaces that will not be needed after construction is complete, there are three long-term grants requested: (1) the transmission line ROW itself; (2) off-right-of-way (ROW) access roads, whether new construction or existing roads managed by federal agencies crossing federally managed lands that are needed during construction, operation, and maintenance; and (3) off-ROW permanent facilities such as communication stations. The legal descriptions to be provided will be based on best available information for each segment and for each element of the Project. Modifications to Appendix E will be filed as appropriate when routes are finalized and when all Project elements are definitively located. A final description will be filed with the “as-built” drawings at the conclusion of construction. Legal descriptions will be prepared based on instructions found in *Specifications for Descriptions of Tracts of Land for use in Land Orders and Proclamations*, USDI Bureau of Land Management Cadastral Survey, rev. 1979.
